## **RULES & REGULATIONS:**

## Institute/school fees

- 1. VTI ltd Institute/school fees include vti ltd tuition-programme fee and other expenses as insurance, remedial classes, library, materials, discount rate for photo copies etc if any
- 2. Institute/school fee has to be paid in full as and when enrolled or by latest within the first month of enrollment .Other mode of payment ie Payment by semester or by monthly would incur an increase as per plan chosen per month. Monthly payment (12/17] months has to be paid in advance on or before the 10<sup>th</sup> of each month.
- 3. Payment of Institute/school fees should be affected as per plan scheme unless prior agreement has been made.
- 4. Crossed cheques to be made payable to Vocational Training Institute Ltd.
- 5. A cancellation fee of 50% of the institute fee will be applicable if cancellation request occurs in writing and within two working class sessions & after no fees will be refunded and but could be transferred for another one session only.
- 6. Tuition programme fees will be refunded only if the course is cancelled/not hold by the institute
- 7. Admission priority will be given at the time of admission, for those [a] paying their fees in full [b] semester wise and [c] monthly
- 8. Uniforms would be compulsory to all full time students at all time during school,
- 9. common hair style for full time[a] girls and [b] boys will be compulsory at all time during school External exam fees
- 10. All external examination ,annual registration membership,, exam registration, module exam fees and MES local fees for students at and through VTI ltd shall include VTI ltd administration chargers, ,cost, commission and accessories, continuous assessment and processing fee and could be changed as a notice only

- Refer[only 2] in practical unit/s will be given to [a] student/s not complying with 1 or 2 or 3 or all above (b) student/s for incomplete work/assignment/p-Folio is/ OR to those absent and/ has/have produced medical evidence and a VTI ltd local refer fee of Rs 100/= per student per sitting per assessment will be charged.

- 14. Student obtaining less than 80 percent attendance will not be accepted onto examination either locally or internationally or both except on management recommendation and discretion
